Notification of change to the underlying fund of our Affected Investment-linked Fund:

**Templeton Latin America (H80)** 

We are writing to you as your policy holds units in the FPIL Affected Investment-linked Fund (the "Affected ILF") named above.

We have been notified by Frankin Templeton Investments (Asia) Limited, as Hong Kong Representative of Franklin Templeton Investments Funds (the "Company"), of a change to the investment management structure of the underlying fund of the Affected ILF, Templeton Latin America (the "Underlying Fund"), with effect 1 October 2025 (the "Effective Date").



## Summary

Currently, the Management Company (Franklin Templeton International Services S.à r.I) has delegated the portfolio management of the Underlying Fund to Franklin Advisers, Inc ("FAV") as the Investment Manager and Franklin Templeton Investimentos (Brasil) Ltda. ("FTIBL") as the Sub-Manager. To reflect an internal reorganisation of investment personnel responsible for the investment management of the Underlying Fund, it is proposed that FAV will be removed from the investment management structure of the Underlying Fund. Please see table below for a summary of the change to the Underlying Fund of our Affected ILF.

The Company assures the above change will have no impact on the features and the risks applicable to the Underlying Fund, nor the operation and/or manner in which it is being managed. The change set out in this letter is not expected to materially prejudice the rights or interests of investors. The investment team at Franklin Templeton has always managed assets based on a team approach and the Underlying Fund will continue to be managed according to the same principles.

The change will not give rise to any change in the fee level/cost in managing the Underlying Fund. Any costs and/or expenses arising from the above change will be borne by the Management Company, other than the cost of publishing the Company's investor notification letter providing notice of the investment management structure change, which is estimated to be approximately HKD5,000 and which will be charged to the Underlying Fund.

This change will happen automatically within your policy or contract and you do not need to take any action.

Should you wish to switch your existing investment out of the Affected ILF, or to redirect future regular premiums (if any) to a different investment-linked fund, you are free to do so, without charge, by completing the Switch/Redirection instruction form and returning it to our Hong Kong office, a copy of which is available on request.



Please note that you can also switch your investment-linked funds or redirect future premiums at any time, online through the FPI Portal, without charge. Simply log in at <a href="https://portal.fpinternational.com">https://portal.fpinternational.com</a>. It is a simple, convenient and secure way to manage your policy.

我們已接獲富蘭克林鄧普頓投資基金(「該公司」)之香港代表 - 富蘭克林鄧普頓投資(亞洲)有限公司的通知,有關受影響之投資相連基金的相關基金 - 鄧普頓拉丁美洲基金(「相關基金」)的投資管理架構將出現變更,並由 2025 年 10 月 1 日(「生效日期」)起生效。



## 摘要

現時,管理公司 (Franklin Templeton International Services S.à r.l ) 已將相關基金的投資組合管理職能,委託予擔任投資經理的 Franklin Advisers, Inc(「FAV」)及擔任分經理的 Franklin Templeton Investimentos (Brasil) Ltda.(「FTIBL」)。為反映負責相關基金投資管理的投資人員之內部重組,現建議將 FAV 從相關基金的投資管理架構中剔除。有關受影響之投資相連基金的相關基金的變更摘要,請參閱下表。
